#### NATIONAL ROAD SAFETY STRATEGY 2012-2020

**Objective:** To reduce the negative impacts of road traffic accidents by ensuring the development of inter-sectoral cooperation and integrating the security of People-Vehicle-Road-Environment system.

#### **Strategic target**

To reduce the road traffic deaths and injuries by more than 50 percent in 2012-2020

#### Strategic main goals

- I. Road safety management
- II. Safer road design
- III. Safer vehicles
- IV. Safe road users
- V. Post-crash care



Implementation of National Road Safety Strategy: The Action plan of National Road Safety Strategy includes 48 targets
By the end of 2018, 60.4% of the targeted activities has been completed.

#### NATIONAL ROAD SAFETY STRATEGY 2012-2020

It identifies 20 indicators for its implementation. It includes the improvement of actions and usage for road engineering, vehicle monitoring, wheel location, seat belt, helmet, alcohol and speeding. By the end of 2018,

7 indicators: 100%

2 indicators: 70%

8 indicators: 30%

3 indicators: 0%

The implementation percentage of the total indicators: 54%.

The compliance of the improvement of legal environment for road safety: 64%.

Steering Wheel Position






Crash call records and patterns in 2007-2016 increased by 6.0 times, and reported crash records in 2007-2016 increased by 6.6 times. 94.4% of total crash call records was received in Ulaanbaatar city, 5.6% was received in local regions.

In 2018, both records have decreased by approximately 30% comparing to the data in 2016.




#### Car Crash Death



In 2013, 623.5 crashes/100,000 population 20.7 deaths/100,000 population.

In 2018, 564.2 crashes/100,000 population, 16.9 deaths/100,000 population.



#### Measures to be taken

- ➤ To join to the three UN Agreements, adopted in 1958, 1997 and 1998, to establish regulatory instruments concerning motor vehicles and motor vehicle equipment.
- To join to the UNECE World Forum for Harmonization of Vehicle Regulations, a unique worldwide regulatory forum within the institutional framework of the UNECE Inland Transport Committee.
- > To implement the Integrated Standards for Road Safety initiated by UNESCAP
- To adopt the Law on Road Traffic Arrangement
- To implement the National Road Safety Program 2019-2023

#### Measures to be taken

#### National Road Safety Program 2019-2023

- ✓ Prevention of drink driving
- ✓ Safer speed
- ✓ Helmet usage
- ✓ Justice responsibility
- ✓ Training
- ✓ Preventing actions
- To provide speeding and alcohol measurement instruments for traffic police administration
- To expand road safety campaigns and communications for the purpose of obtaining good behavior
